April 26th, 2017

Called to Order 7:04PM

Kevin motioned to approve March meeting minutes. Tom seconded. Approved.

Nancy agreed and everyone else also. County water issue dropped. We will fix urinal and other fixtures if and when they break.

Nancy has requested that we all have a sympathetic ear to whoever complains about hooligans using the park, but we should not call the police unless we see a reason first hand. We do not want false calls to be coming from the board. We can inform people they can call the police if they deem it necessary. We as a board should not over react.
