#### **Reminders:**

#### **LHO Neighbor Spotlight**

Art and Susie Heinrichs purchased their house on Palamore Drive in 1991. It's where they started and raised their family, where they participated in countless LHO events – one of Art's favorites was when Santa visited in a horse drawn sleigh - and it's where they and their children, Allie and Tyler, have made lifelong friends.

LHO "has everything you could ever want," Susie recently commented. She and Art have always thought of LHO as a special place. And it *is* a special place because of the people who live here – people like the Art and Susie Heinrichs.

Art is a founding member and Senior Vice President/Corporate Compliance Officer of Lifelink Foundation, a non-profit community service organization established in 1984, dedicated to the recovery of life-saving organs and tissue for transplantation therapy.

Susie and Art met in 1988 when she relocated to Tampa from Pittsburgh, PA to work as a transplant coordinator for Lifelink. They married in 1990.

Susie has been a practicing physician's assistant at the Florida Orthopedic Institute for the past 33 years. It's through her work that she became acquainted with Operation Walk, a nationwide humanitarian mission that provides free hip and knee replacements to patients in very poor countries with no medical infrastructure.

Since 2004, Susie has travelled to Cuba, El Salvador, and Guatemala as part of the mission. Most of her visits have been to Guatemala where patients come from all over the country to receive the surgery.

"Once a patient is no longer able to provide for their family or village due to limitations of their degenerative disease, they can often be ostracized by their community. Regaining mobility allows patients to continue to take care of their families," explained Susie.

Earlier this year a new chapter - Operation Walk Florida – was started. Susie is the Team Leader and is in charge of coordinating the entire trip. She organizes volunteers, chooses which patients will receive surgery, and performs surgeries.

This year Art also began volunteering for Operation Walk Florida. He is in charge of coordinating cargo and logistics – he makes sure everything, from paper to instruments to medications to walkers and canes, makes it to their destination. "It was a natural fit," he said.

On their most recent visit, a team 47 volunteers made up of physicians, physician's assistants, anesthesiologists, nurses, interpreters – essentially a small hospital staff - travelled to Guatemala where they successfully performed 45 surgeries, which included 48 knee replacements.

"There are over 5000 patients on the waiting list in Guatemala alone," said Susie.

Each effort requires two trips – one in April to do all the prep work, and a weeklong trip in August when the team sets up, and conducts pre- and post-operative exams, leaving about 3  $\frac{1}{2}$  days to perform the surgeries. In that time, the mission averages roughly 45 - 50 patients.

While the mission covers room and board for its volunteers, each volunteer pays for their own travel expenses. But to the Heinrichs, it's well worth it just to hear the stories of patients reclaiming their lives.

"It's a life-changing experience for them," Susie added.

Aside from spending time with their grown children, in their spare time, Art enjoys cooking and gardening, and Susie enjoys baking and photography.

### Lake Heather Oaks Preliminary Walk-Through Results

Last month board members and volunteers conducted a preliminary walk-through to gauge where we are as a community with upkeep. The chart below provides an overview of what we found. The most common issues which need addressing include:

- mold and mildew visible
- rotting wood
- yard in need of maintenance
  - edging (including at sidewalks and streets)
  - overgrown landscaping and/or weeds
  - edging (including at sidewalks and streets)
  - o overgrown landscaping
  - o lawn/landscaping overgrown with weeds
  - garbage cans consistently visible from the street or adjacent lots

An official walk-through will be conducted early next year. Homes that score below expectation or have continuous violations will continue to be notified by letter and/or email.

In the meantime, courtesy notices are being emailed to allow

homeowners an opportunity to address the issues prior to the annual walk-through.

Doing so allows us to maintain property values, support the investments we have made in our homes, and ensure that the community continues to thrive and that it remains appealing to both current and prospective homeowners.

#### Weed Management Guide for Florida Lawns

#### From the University of Florida Institute of Food and Agricultural Sciences (IFAS) website

It is essential to properly maintain turf to minimize weed invasion. If weeds become established, several methods of control are available.

**Mowing**—Many weeds can be eliminated if proper mowing height and frequency are maintained. Some weeds, however, readily establish below the desired mowing height. Management requires additional control methods. As a rule of thumb, when mowing, remove only a third of the turf's leaf blade at a time. This maintains a turf canopy that can grow vigorously while shading weeds and suppressing growth.

**Hand-pulling or rogueing**—If only a few weeds are present, it's easier to physically remove the plant. When hand-pulling weeds, it is critical to remove the roots and underground parts to ensure the weeds will not survive and produce new shoots. Some weeds might require the use of a small shovel to dig out the roots.



**Smothering**—Smothering with nonliving material to exclude light is effective in certain areas where turf is not grown, such as flower beds, or foot paths. Materials used for this include mulch, leaves, rocks, and plastic film. To be effective, a minimum of 2" is required when using natural mulch materials. As an alternative, synthetic mats impregnated with herbicides can be used.

Herbicides—Herbicides are safe and effective if product label instructions are followed. Herbicide application timing during the plant's growth cycle is important.

#### HERBICIDE TYPES

**Selective**—A selective herbicide controls certain plant species (weeds) without seriously affecting the growth of other plant species (desired turfgrass). Most herbicides are selective herbicides. Herbicides are selected based on the turfgrass species, simplifying the application because it can be applied over the turf without injuring it.

**Nonselective**—Nonselective herbicides control green plants regardless of species. They are generally used to kill **all** plants, such as in the renovation or establishment of a new turf area, as a spot treatment, or to trim along sidewalks. These herbicides injure turf. Therefore, in an established turf, their use is usually limited to spot applications for weedy patches, **which must be followed by reseeding or resodding the treated area**.

**Contact**—Contact herbicides affect only the portion of green plant tissue contacted by the herbicide spray. Therefore, they do not kill underground plant parts. Repeat applications are often needed with contact herbicides to kill regrowth from these underground plant parts.

**Systemic**—Systemic herbicides are translocated in the plant's vascular system. The vascular system transports the nutrients and water necessary for normal growth and development. Systemic herbicides generally are slower acting and kill plants over a period of days.
