- 4. Approval of draft summary minutes from prior meeting (July)
  - i. All in favor and approved.
- 5. Approval of Financial Report
  - i. Treasurer's report will be tabled to the October meeting due to discrepancies.
  - ii. Should have a little over \$62k by end of year after all expenses paid out
  - iii. Kevin shared rates were no longer being offered via Fifth Third Bank so haven't opened the CD/high yield account
  - iv. Motion made by Kevin Wilkins to fund one or more "high-yield" CDs for a term not to exceed 7 months, and/ or a "high-yield" savings account, in the combined total amount of \$25,000.00, in a federally insured bank, credit union or other financial institution, with the President (Sarah Riordan) and Treasurer (Kevin Wilkins) to be authorized signatories on account. - 6. Updated LHO Deed Restrictions are being filed with the State-
  - Sarah reported that she, Mardee and Kevin and Vince on Zoom with the attorney and they are now being filed with adjustments discussed in the special meeting.
- 7. Review current LHO Guidelines and discuss changes
  - i. Sarah please review Guidelines document with track changes and give

feedback especially on the Motor Vehicle guidelines. The Guidelines must coincide with the deed restrictions and the current deed restrictions in order to simply clarify but not to conflict with the verbiage used in the approved deed restrictions.

- ii. Mardee additional input on Motor Vehicle (no commercial vehicles could not be added in the guidelines)
- iii. Sarah will be consulting an attorney to be sure all is good as the guidelines are being clarified.

# 8. Updates from ARC-

- i. Mardee Increase in people not cleaning up after dogs. Have had a few instances with very ugly actions towards neighbors who don't pick up. County code states to pick up after dogs, as well as keep dogs leashed. We will post in FB and on the newsletter to add Animal Control numbers.
- ii. Stormwater drainage is being blocked and Mardee has open case numbers to address stormwater.
- iii. Mardee will be reaching back out to TECO regarding the easement maintenance and bollards installed time frame.
- iv. Don Walls has been assisting Mardee with his own contacts with TECO.

- 10. Park Security Update-Justin
  - i. Request from a homeowner to see video footage about a dog biting a young child but nothing was captured. Investigation is occurring.
  - ii. Sarah will reach out to the Deputy who is investigating to follow up about the dog owner, if they live here, what is the outcome so the neighborhood is aware.
  - iii. Some cameras are not charging and don't record continuously. Our cameras will capture motion for 30 seconds after motion has occurred.
  - iv. Justin will be addressing the camera issues.
  - v. Justin to have a proposal by weekend

  - ii. Not doing the shoe donations anymore received \$17 total!
