# **Barnes Park Improvement Initiative Fundraising Update**

Thanks to all the community donations and the undying commitment of Courtney Cardisco, the main play structure at Barnes Park has been replaced. The semi delivering the equipment arrived on December 2, 2024, and by the end of the day it was ready for play.

Nearly \$16,000 was collected through personal donations and fundraising activities. Add to that the \$5,222 that would have been spent on the Fall Festival, which was cancelled due to Hurricane Milton, we had the \$21,000+ needed to purchase the new structure.

If you missed the opportunity to donate to this worthy cause it's not too late. Next on the list of park improvements is replacing the swing set at an estimated cost of \$7,000.

Donors will be recognized with their names included added to the tree mural that will soon be painted on the park pavilion.

#### **LHO Awarded Hillsborough County Grant**

In addition to our playground equipment, our Board applied for a Hillsborough County grant to help improve our park by promoting a healthy and engaged community. We were fortunate to get the full amount of the grant which is \$4,750.00. The scope of the project includes a Fitness walking trail and two stopping points - a cardio workout station and a core workout station, with potential to build on this as we get additional funds.

Homeowners already use our park for personal enjoyment and our community has traditional events to engage the neighborhood. The addition of a fitness trail will enhance a healthy lifestyle and allow members of the community to come to the park not only to play, but also, to exercise. The fitness trail will be geared towards all age levels.

#### Reminder about exterior home improvements

This includes all improvements that are visible to neighbors, including painting. The approved LHO paint color palette can be found on the Sherwin Williams website - https://www.sherwin-williams.com/homeowners/color/find-and-explore-colors/hoa/tampa/fl/lake-heather-oaks/. The *Exterior Improvement Request Form* can be found on the LHO Website, or you can scan the QR code below.

**Exception:** If you are replacing items (fences, shutters, windows, etc.) damaged during hurricane Milton with the same materials, color, etc., <u>you do not</u> need submit an Exterior Improvement Request Form.

The flooding of the lake caused the platform to lift off the pillars making the dock unsafe for use.

The Board has acquired quotes to repair and is working on hiring a contractor and getting repairs scheduled.

In the meantime, PLEASE DO NOT USE THE DOCK until repairs are completed – it is unstable and very dangerous.
